
2. The Technical Teams assigned shall:
- Witness the distribution of test materials at the division office
  - Monitor the administration of the examination
  - Fill up the Monitoring and Evaluation Form

3. Subjects to be tested:
  - Elementary – English, Math, Science, Filipino, Hekasi, MSEP, EPP
  - Secondary – English, Math, Science, Filipino, Araling Panlipunan, MAPEH
4. Selection of schools to be tested:
  - Elementary – 100% for Central Schools and 25% for non-central
  - Secondary – 100% for division lead schools and 25% for regular schools
5. Distribution of test materials:
  - Test materials will be distributed to the schools divisions on February 21, 2012 starting 9:00 a.m. in the following venue:
    - Panay and Guimaras Area – DepED Reg. Office, Duran St., Iloilo City
    - Negros Area – DepED Sub-Regional Office, Rizal St., Bacolod City
6. Test administration:
  - One (1) room examiner per testing room. He/she must come from other district within the division.
  - One (1) chief examiner per testing school. School Principal/Head will serve as Chief examiner in his/her own school. Chief Examiner will receive test booklets from the division offices.
  - One (1) supervising examiner per 3 or less testing rooms. He/She must come from other division.

**Note: Test booklet will be opened in the presence of supervising examiner.**
